## Peeps Diorama Contest Official Rules

### What is a diorama??

A diorama is a way to build an exciting scene in a small space. They usually display a historical time period, a nature scene, or a fictional situation, and allow a lot of room for creativity and innovation.

### How to Enter

1. Think of a scene. Sketch some ideas. Possible extra credit given to those who deftly employ puns in the diorama concept or title.
2. Make your diorama using a shoebox or comparable item of reasonable size not to exceed three feet wide by two feet deep by two feet tall.
3. Melt, mold and manipulate those fluffy chicks and bunnies to bring your creative vision to life.
4. Entries due by Friday, April 14, at Discovery Ridge Adventure Center. To be eligible for finalist standing, the diorama must be transportable to the Discovery Ridge Adventure Center.

### You will need to provide

Entries without this information will not be considered. Prizes will be awarded.

- a. Your name, age and home town
- b. The names, ages and home towns of anybody who contributed to the diorama
- c. A phone number and e-mail address (not for publication)
- d. The title of your diorama
- e. Captions accompanying your photos about your creation or its significance

#### LIMITATION OF LIABILITY AND GENERAL CONDITIONS

By participating in this Contest, entrants agree to be bound by these Official Rules and the decisions of the judges, which are final and binding in all respects.
